LETTER

from the **DIRECTOR**

When I joined OSI-Baltimore in January 2020, I had no idea that my first year with the organization would be as challenging—nor, ultimately, as rewarding and transformative—as it wound up being.

In many ways, the COVID-19 pandemic and racial reckonings of the year lifted up existing inequities and tensions and encouraged more intentional, comprehensive thinking about how to address them. In our year-end newsletter, we described some of the many ways OSI-Baltimore pivoted to meet this crucial moment, including our involvement in public-private partnerships like the COVID-19 Emergency Assistance Program, Baltimore Health Corps, and Healing City Baltimore.

We also supported campaigns to decrease the Baltimore City police department budget by \$100 million over two years, to reform Maryland’s criminal code to reduce its disparate impact on marginalized communities (the People’s Commission to Decriminalize Maryland), and to establish a community-led grantmaking initiative to advance community-based solutions, collaboration, and racial justice (B’more Invested).

Of course, this is just a sampling of the wide range of efforts OSI has supported, along with our many partners. In these pages, you’ll find a comprehensive listing of OSI-Baltimore’s grantmaking in 2020, along with a list of OSI donors who helped us underwrite this work.

We look forward to continuing the momentum that we and our partners have established toward a more just and liberated future for all Baltimoreans.

Addiction and Health Equity Grants

OSI-Baltimore's Addiction and Health Equity Program seeks to generate and promote innovative ideas that improve health equity and lower the threshold to high-quality behavioral health services, reduce stigma, and support community engagement to improve public health in Baltimore.

Baltimoreans United in Leadership Development, Inc.

\$25,000 over one year to provide support to Turnaround Tuesday, a program of BUILD, for returning citizens by conducting essential skills training, case management, job readiness, and job placements services in response to the challenges presented by COVID-19.

Behavioral Health Leadership Institute

\$110,000 over 18 months to support a mobile treatment van that provides buprenorphine, when appropriate, to individuals as they are released from the state-run Baltimore City jail.

Charm City Care Connection

\$200,000 over two years to provide general support.

Communities United**

\$139,721 over one year to support policy advocacy on harm reduction and drug decriminalization.

Disability Rights Maryland

\$50,000 over one year to convene consumers and advocates to create equity and justice in public behavioral health care through education, community involvement, and policy reform.

Criminal and Juvenile Justice Grants

OSI-Baltimore's Criminal and Juvenile Justice Program seeks to reduce the use of incarceration and its social and economic costs without compromising public safety, and promote justice systems that are fair, are used as a last resort, and offer second chances. It supports advocacy, public education, research, grassroots organizing, litigation and demonstration projects that focus on reforming racial and social inequities at critical stages of the criminal and juvenile justice systems—from arrest to reentry into the community.

\$100,000 over one year to engage in outreach and education to reduce the number of youth impacted by Maryland's juvenile justice system, with fewer young people involved at every level.

50,000 over one year to increase the capacity of the Baltimore Action Legal Team to improve police accountability, reduce pretrial incarceration, and engage Baltimore lawyers in supporting local social and racial justice movements.

\$95,000 to enable the Mayor's Office of Criminal Justice to meaningfully engage community partnerships critical to reduce violence in Baltimore, without a reliance on incarceration.

Education and Youth Development Grants

OSI-Baltimore's Education and Youth Development Program seeks to ensure that all student groups are fully included in schooling and other opportunities that prepare them for success in adulthood. Equitable education provides the most accessible egress out of the crippling cycle of poverty. It is most readily achieved by removing prohibitive barriers and nullifying inequitable practices that push children out of school and into the school-to-prison pipeline.

Attendance Works

\$100,000 over one year to enable Attendance Works to provide extra support to students facing challenges in a new remote learning setting and to ease the transition back to school as a key focus of their 2020 Attendance Awareness Campaign.

\$200,000 over one year to support the Emergency School Closure Family Support Fund to provide vital resources to families and schools during school closures caused by COVID-19.

Through Building Our Nation's Daughters (BOND), Ateira is encouraging healthy two-generation relationships, economic mobility, and educational achievement by providing single mothers and their daughters in grades 5 to 12, with mentoring, counseling, education, and career support.

Through the Parole Hearing Preparation Project, Elizabeth is working to systematize parole hearing preparation by developing appropriate and effective materials, by empowering inmates and their family members to make their best case for parole release, and by engaging and guiding volunteers to support people in parole hearing preparation.

Bree is establishing Parity, an equitable housing development company that

is building a collective of motivated individuals who are cooperatively reviving West Baltimore neighborhoods through homeownership, civic engagement, and development without displacement.

and social development needs of McElderry Park's young people, incorporating the goals and passions of participants.



E.V. YOST

E.V. is establishing The Queer Crisis Response Unit (QCRU), an emergency

services alternative designed to reduce the collateral consequences of criminalization experienced by the TLGBQIA+ survivors of interpersonal and systemic violence in Baltimore City.

youth to positive role models who will assist them with developing life skills, healthy coping skills, and sound decision-making skills.

ADDITIONAL COMMUNITY FELLOWSHIPS GRANTS

OSI-Baltimore's Community Fellowships Program seeks dynamic activists and social entrepreneurs interested in implementing projects that address problems in underserved communities in Baltimore City. Launched in 1998, the Community Fellowships Network is now a corps of social innovators 210 strong.

\$45,000 over 18 months to provide support to strengthen organizations founded by Baltimore Community Fellows by identifying specific needs and opportunities for various types of volunteer services and matching the organizations with appropriate volunteers.

A New Faith Community

\$25,000 over one year to provide general support.

SPECIAL PROJECTS: COVID RESPONSE

OSI-Baltimore invested nearly \$2 million in direct response to the COVID-19 and its economic fallout. This included \$1 million in direct financial and other emergency support for Baltimore workers hardest hit by the pandemic and at greatest risk of falling into extreme hardship, including those who are unemployed and the formerly incarcerated, and \$750,000 in rapid-response funding for at-risk populations.

COVID-19 Emergency Assistance Program

OSI-Baltimore partnered with Baltimore City, leveraging \$6 million in public funding to distribute \$400 prepaid cards to up to 15,000 Baltimore City residents hardest hit by COVID-19 and its economic impact. OSI supported 13 community based organizations to facilitate distribution of the emergency resource.

SPECIAL PROJECTS: COVID RESPONSE

Rapid-Response Funding for At-Risk Populations

OSI-Baltimore's Addiction and Health Equity and Criminal and Juvenile Justice programs collaborated on a request for proposals to distribute more than \$700,000 in rapid response funding to provide critical support to Maryland residents who use drugs, are incarcerated, or were recently released from incarceration, and thus were at increased risks of contracting COVID-19, suffering a fatal overdose, or being re-incarcerated.

Election 2020

OSI-Baltimore responded to the unprecedented pivot to a vote-by-mail election in 2020 by supporting local advocates' innovative efforts to educate and promote voting in marginalized neighborhoods in the primary election, resulting in unprecedented voter participation in Baltimore City and the use of OSF funds to scale these efforts to several cities in the general election.

\$75,000 over one year to enable Baltimore Votes to ensure widespread participation for 2020 elections in Maryland, particularly among marginalized communities in Baltimore City, in light of challenges presented by the COVID-19 pandemic.

Open Society Foundations invested \$21 million in eight cities, including Baltimore, to reimagine public safety and create transformative models of safe, healthy, and racially just communities. 
